

購買進階型 / 專業型 / 企業型憑證使用者須知

凡購買進階型 / 專業型 / 企業型 SSL 憑證使用者之客戶，因為其為『組織驗證』等級，需要對您的公司進行完整查核，故必須要進行「國際徵信」及「電話驗證」等程序。請先確定您有辦法提供下列相關文件 (3 擇 1)，如沒有辦法提供，則建議您購買 DV 網域驗證型憑證 (單域名基本型 / 單域名通用型 / 多域名基本型 / 多域名通用型)。

相關應具備文件如下：

- 國際貿易局進出口英文登記證明函 (需公司所營事業資料有登記 F401010 國際貿易業) 方可申請
- 鄧白氏環球編碼
- 律師函或會計師函

當您填寫資料時，憑證發證單位即會對您的網站進行實際查核，然而因為中華民國公司的註冊資訊均是以中文登記註冊，並不像國外有一個正式的英文公司名稱，所以造成在購買組織驗證級憑證容易造成驗證不過的困擾，茲將說明與圖例分別敘明如下：

● 律師函 / 會計師驗證信

(一) 執業資格：

✚ 律師與公證人：

- 律師：須在申請人辦公室或實體設施所在之國家得到執業許可，並且在申請人的登記管轄權或註冊的任何管轄區內執業。
- 公證人：須為國際拉丁公證人聯盟之會員，並且是主管機關認可拉丁公證人的角色。

✚ 會計師：

須在申請人辦公室或實體設施所在之國家具備執照，並為執業的會計師執筆繕寫，而該國家必須有會計標準機構與國際會計師公會 (IFA) 具有正式成員之資格。

(二) 意見的基礎：

憑證註冊單位必須驗證執業律師 / 會計師正行使代表申請者，並根據執業律師 / 會計師陳述熟悉相關事實與運用專業知識和專業判斷來檢驗律師函 / 會計師驗證信的結論。

(三) 內容真確性：

憑證註冊單位須確認律師函 / 會計師驗證內容之真確性。

會計師應至申請組織進行實地查核驗證，並確認該公司 / 社 (財) 團法人為正常設立登記且業務亦為正常運作，並使用英文繕寫會計師驗證信，內容應包括：

- (A) 公司 / 組織登記名稱
- (B) 經向政府登記營運使用的名稱及其商標
- (C) 實際營運地址的拜訪與確認
- (D) 實際營運電話的確認
- (E) 銀行帳號的確認 (必須直接取得銀行的認證函件)
- (F) 公司負責人的確認 (或取得公司年度股東會議記錄)
- (G) 取得公司負責人及合約簽署人的信件，確認在申請書上的合約簽署人、批准人之姓名。

成立未滿三年之公司或組織，需佐以銀行英文版存款證明備查，但一般銀行開立之存款證明僅有包含戶名、帳號、餘額、但是因作為審核備查文件，該存款明證明須另具備**組織名稱**、**地址**及**電話**等資訊，然而具備前述資訊之存款證明文件因簽核層級較高，申請的時間也會相對較長 (約 7-10 個工作日)
